

Wise Trade Safety Free T-Shirt Claimback- 2022



TERMS AND CONDITIONS

These terms and conditions (Rules) form the agreement between Wise Trade Safety and entrants in relation to the Wise Trade Safety Free T-Shirt Claimback campaign 2022.

(Promotion). For the purposes of these Rules, reference to “entrants” is a reference to the party entering the Promotion. By participating in the Promotion, entrants are deemed to have accepted these Rules. Any Rules in favour of Wise Trade Safety will apply to all Entrants, as applicable.

Promotional period is from 1 September – 30 September 2022. To receive a free T-Shirt, simply spend \$150 (incl. GST) on Wise Trade Safety products at any Wise Trade Safety official reseller store during the promotional period then enter online at wisesafetymedia.com/freeshirt. Entries close at 11.59pm on 30 September 2022 (Expiry Date).

\$150incl. GST can be accumulated across up to 3 receipts during the promotional period for the single entrant. Entries are limited to 1 per entrant. The prize is a free Wise Trade Safety T-Shirt.

How to enter:

- The Promotion is open to New Zealand residents.
- Spend \$150 (incl. GST) accumulatively during the promotional period at any one Wise Trade Safety stockist (Qualifying Spend).
- Submit your entry by entering the requested details and uploading the related receipt/s to the Qualifying Spend at [Wise Trade Safety.co.nz/fishinglegends](https://wisesafety.co.nz/fishinglegends) by the Expiry Date. The requested details include:
 - o Contact name
 - o Email address
 - o Phone number
 - o Store associated with the Qualifying Spend
 - o Address
 - o Image of Receipt
- Wise Trade Safety reserves the right to exclude/disqualify any person from participating in the Promotion on reasonable grounds (including, without limitation, where the person has interfered with, corrupted or adversely affected the administration, security, fairness, integrity or proper conduct of the Promotion).
- Wise Trade Safety reserves the right to refuse to award any prize to an entrant who Wise Trade Safety decides (in its sole discretion) has violated the Rules, gained unfair advantage in participating in the Promotion or won using fraudulent means.
- Employees of Wise Trade Safety and associated companies and each of their immediate families (i.e. spouse, parent, child or sibling) are ineligible to enter.
- By participating, entrants grant Wise Trade Safety exclusive permission, to use their names, characters, photographs, videos, voices and likeness in connection with the Promotion and for future promotion and marketing purposes and waive any claims to royalty, right or remuneration or compensation for such use. Entrants also grant such rights to Wise Trade Safety and entrants acknowledge that each Entrant may be required by Wise Trade Safety to sign a publicity release to this effect.
- All entrant personal details must be valid and up to date and will be held by Wise Trade Safety and may be used for the purpose of the Promotion.

Winning the prize

- Wise Trade Safety is not responsible for any notification that is misdirected or lost, or if the winner cannot be contacted due to incorrect details being provided on the trade account associated with the winner’s winning entry (or for any other reason).

- In the event that the prize (or any part of the prize) becomes unavailable for any reason Wise Trade Safety may substitute the prize with a prize of equal or greater value.
- The winner takes the prize entirely at his/her/its own risk and indemnifies Wise Trade Safety in respect of any claim for any accident, injury, property damage or loss of life and any other loss, harm, damage, cost or expense that may occur in connection with the prize, including its use by the entrant and the Entrants.
- All receipts relating to the Qualifying Spend must be paid by the winner on or before the dates specified by the relevant Wise Trade Safety store, otherwise the prize is forfeited by the winner. The winner may only claim the prize if payment of all receipts issued to the winner by any Wise Trade Safety authorised re-seller store are up-to-date. In addition, if any such receipts are overdue at any time between the commencement of the promotional period and the time the prize is redeemed, the prize is forfeited by the winner.
- Wise Trade Safety reserves the right to amend, vary, extend or discontinue this Promotion at any stage, for any reason.
- To the fullest extent permitted by law Wise Trade Safety will not be liable for any loss or damage whatsoever (whether direct, indirect, special or consequential) or for personal injury in any way associated with the Promotion or the prize (including the winner accepting and/or using the prize), whether in contract, tort (including negligence) or otherwise.
- Where the prize is to be supplied by an entity outside Wise Trade Safety control and that entity fails, for whatever reason, to supply the prize, Wise Trade Safety has no responsibility for the provision of the prize and is not obliged to provide an alternative prize or to take legal action to require the prize supplier to provide the prize.
- Please allow 2-3 weeks for delivery. However this may extend past this period as 3rd party printers may experience delays beyond our control.

Privacy

- To participate in the Promotion, certain personal information is required to be provided to Wise Trade Safety by entrants. This includes personal information submitted by an entrant as part of their entry into the Promotion (such as name and contact details). Such personal information will be used by Wise Trade Safety for the purposes of conducting this Promotion. If the entrant or Entrants fail to provide the personal information to Wise Trade Safety, the entrant may be unable to participate in the Promotion or claim the prize.
- Wise Trade Safety may disclose the personal information to third parties, including third party suppliers of the prize and service providers who assist in conducting this Promotion.
